Exhibitor/owner certifies that any and every dog they bring to this facility, whether participating or not, is not a hazard to persons, dogs, or property and assume all responsibility, liability and expenses resulting from damages caused by their dog(s).

Exhibitor/owner certifies that the entered/training dog is not a hazard to persons, dogs, or property and that the entered dog's rabies vaccination is current in accordance with the requirement of the county in which the dog resides.

Exhibitor/owner releases John Nunes, NAF; Nunes Agility Field, LLC and it's volunteers. Dr. Julie Meadows DVM, Dr. Jim Quinley DVM, Veterinary Medical Center of Turlock, Meadows-Quinley Partnership, Hypower Hydraulics, and VAST; Valley Agility Sport Team, it's Board of Directors and volunteers and will defend them and hold them harmless from all present and future loss, injury, damage, claims, demands and liabilities involving your dog, and/or others equipment.
